Role Overview

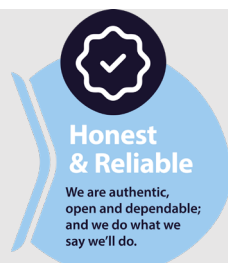

RESPONSIBILITIES

- Build efficient and effective DM capabilities around the needs of the organisation using the appropriate technology to deliver data and information services such as Business Glossaries, Data Catalogue and Data Lineage tracing, while centrally owned, developed collaboratively through engagement with the business SME community.
- Responsible for the delivery of the DM service offerings, in line with agreed budgets and to the target levels of service and quality, and in line with ICT and Business Governance frameworks.
- Responsible for the delivery of the DM solutions in line with agreed budgets, capability and timeframes.
- Ownership of DM technical and functional roadmaps that align to and support the current and future business strategy.
- Lead the operation of the Group data management capability covering data governance, cataloguing and data quality and ensuring it is closely aligned with existing compliance requirements and Info-Sec standards and principles.
- Lead data management programmes and initiatives and projects, such as Data Governance Working Groups, Data Stewardship/Ownership, Golden Record Sets, Data Lifecycle Management.
- Delivery of trusted data providing single-version-of-truth data record of business activity, appropriately documented and curated, and supported and explained by artefacts such as Business Glossary, Data Dictionary and Data Lineage mapping.
- Develop and implement a framework of formalised policies and guidelines to steer and support the business through changes to the data landscape and the day-to-day management of the organisations data, working in close collaboration with the Head of Information Security in areas such as Security, Privacy, Compliance Principles and Ethics.
- Undertake additional duties appropriate to the role and/or grade.
