Key Responsibilities:

6. Remove items of furniture and other personal possessions for disposal. Items to be removed from all floors including lofts and gardens onto appropriate vehicles or skips
7. Enter loft spaces in order to clear possessions where necessary
8. Effectively remove and dispose of all drug related paraphernalia ensuring compliance with relevant Health & Safety legislation
9. Remove and dispose of all animal fouling ensuring compliance with relevant Health & Safety legislation
10. Undertake horticultural practices necessary for the clearance and restoration of gardens to a manageable standard to include grass cutting and hedge trimming
11. Use of a variety of hand, battery and petrol tools / equipment to facilitate gardening clearance and restoration works
12. Van stocks usage & compliance.
